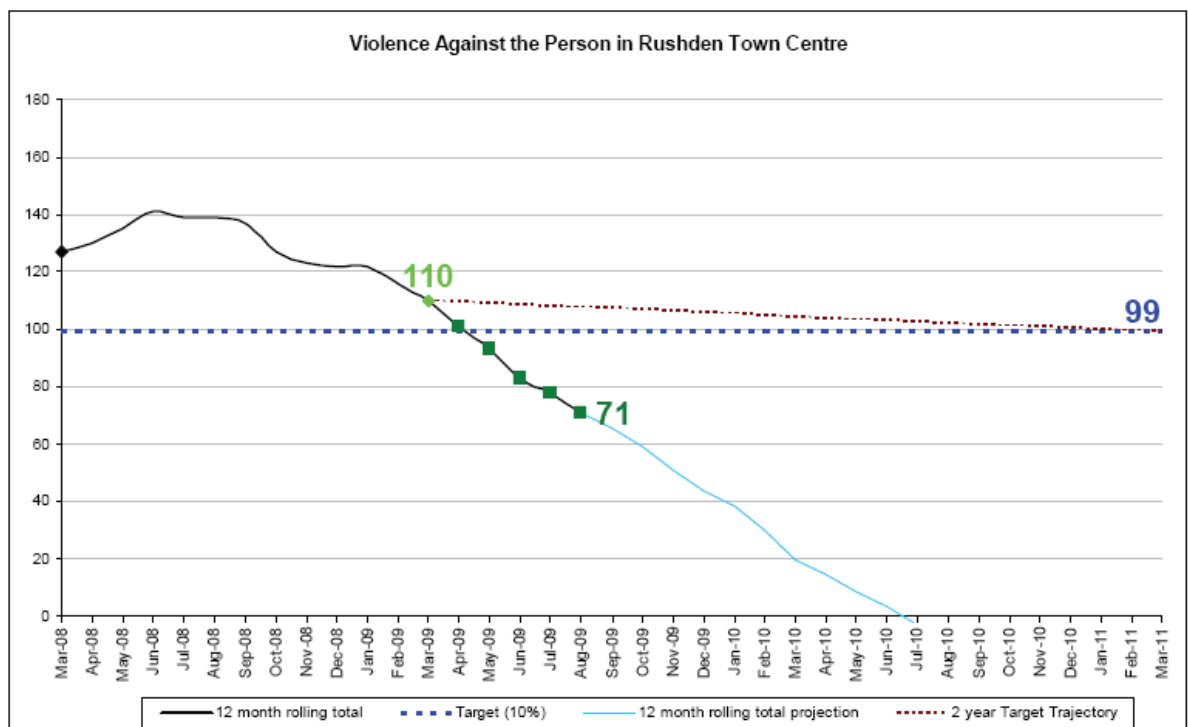
1.0 Introduction

1.1 In March 2007 the Committee received a report detailing various issues raised as a result of the Licensing Act 2003. As part of this discussion, Members asked that they receive information relating to crime associated with licensed premises every six months.

2.0 Crime Statistics

2.1 The attached report is provided to East Northamptonshire Council every month and details the crime which is reported against each premises. It does not include crime outside or near to these premises. The report details the name of the premises, type of offence and the number of crimes.

2.2 In addition to the information provided by premises, the Police have given us some general information relating to violent offences. Since March 2008, town centre violence in Rushden has been reducing, and this is highlighted in the graph below:



3.0 Conclusion

3.1 This information is provided for Members for information and to assist them in identifying the impact of the licensed trade on crime and disorder. Subject to any points Members wish to raise, it is recommended that the report be noted.
