## 1.0 Summary

1.1 An application to review the premises licence at Luvly Jubbly was received on 2 February 2016 from Northamptonshire Police. The appropriate Blue Notice was displayed on the premises during the required consultation period.

#### 2.0 Application details

2.1 The matters for which a review to the premises licence is sought, relate to the prevention of crime and disorder licensing objective. The main reason for the review request is in relation to breaches of the following licence condition:

On any day the premises remains open after 04:00 from 03:45 a minimum of two SIA registered door supervisors must be employed at the premises. On any day the premises does not employ SIA registered door supervisors, licensable activities shall cease at 03:45 and the premises shall close at 04:00.

3.1 The Licensing Enforcement Officer has submitted a representation to support the review application. The representation relates to the joint meeting held between the licence holder, PC Bryan and the Licensing Enforcement Officer and known incidents that have occurred as a result of the breach of the licence condition.

3.2 The Planning Service at East Northamptonshire Council has also made a representation to the review under the grounds of prevention of nuisance, the licensed premises is in breach of its planning condition which states:

The premises shall not be open to the public before 08:30 hours on any day, nor after 23:00 hours on Sundays to Thursdays and 23:30 hours on Fridays and Saturdays.

Planning Enforcement are dealing with this issue.

#### 4.0 Determination

- 4.1 The Panel must carry out its functions to promote the licensing objectives having regard to:
  - Licensing Policy

- 4.2 The Act states that following a hearing the Panel may take the following actions if they deem them necessary to promote the licensing objectives:
  - a) no action necessary as no steps required to promote the licensing objectives;
  - b) issuing an informal warning to the licence holder and/or to recommend improvement within a particular period of time. This Licensing Authority regards such warnings as important mechanisms for ensuring that the licensing objectives are effectively promoted and any warning issued will be in writing to the licence holder.
  - c) to modify the conditions of the premises licence (including adding new conditions, altering/omitting an existing condition);
  - d) excluding a licensable activity from the licence;
  - e) remove the designated premises supervisor,
  - f) suspend the licence for a period not exceeding three months;
  - g) to revoke the licence.

#### 5.0 Policy Considerations

Only mandatory conditions and conditions relevant to the operating plan will be imposed except where relevant representations against an application are received. Where relevant representations are received then further additional conditions to meet the licensing objectives may be added provided they are appropriate, proportionate and reasonable and deal with the issues raised. Licence conditions will not be imposed where other regulatory regimes provide sufficient protection to the public (e.g. Health and Safety at Work and Fire Safety legislation).
  - 2.14 In considering licensing hours this Licensing Authority will place significant emphasis on the individual merits of an application. In addition, the

I act on behalf of the Chief Officer of Police Mr Edens, he has delegated responsibility and authorised me to act on his behalf with regard to representations made by Northamptonshire Police to Licensing Authorities across the county of Northamptonshire.
I call for the Review of the Premises Licence for Luvly Jubly under the Licencing Objective of the Prevention of Crime and Disorder.
This Review will relate to Public Order incidents at the premises and a breach of the Premises Licence.

Please provide as much information as possible to support the application (please read guidance note 3)

At approximately 04:20am on Sunday the 20<sup>th</sup> of September 2015 a public order incident happened at Luvly Jubly. Police Officers were assigned to an area and were dealing with approximately 100 members of the public who had exited a licensed premises situated opposite Luvly Jubly. The licensed premises had stopped trading at 04:00am and customers were leaving with some making their way to Luvly Jubly to purchase food.

Police Officers describe the members of the public as peaceful, however some who enter Luvly Jubly become disorderly and a fight ensues. Due to the scale of the disorder the staff working at Luvly Jubly eject everybody from within, it is one Officers opinion that the staff had lost control of their customers, to support the Officers opinion it is stated that Door Supervisors who were still present at the licensed premises opposite have crossed the street to Luvly Jubly in an attempt to prevent further disorder.

The disorder continues outside and in the vicinity of Luvly Jubly, the Officer states that once all the customers were ejected and the disorder is in the street the staff reopen Luvly Jubly and allow customers back in. The Officer states that during the disorder there are over 30 people shouting and abusing each other and people not directly engaged in disorder were enjoying food that they had purchased from Luvly Jubly and loitering to view the spectacle, clearly re-opening the shop did not assist in quick dispersal.

The Officers opinion of this incident (taken from the E-mail sent to the Police Licensing Department) is that the later opening times of Luvly Jubly means that the people who exit the licensed premises opposite Luvly Jubly who have predominately been peaceful and have had plenty of space within the licensed premises then all try to enter Luvly Jubly at the same time, this in turn packs them in and people get annoyed with each other, causing what the Officer describes as a 'pressure cooker' and fighting ensues. Then the lack of access through the door for Police Officers or a suitable clear exit for anyone attacked inside and wants to escape appears to be unsafe.

The nature of this incident meant that Officers were at one stage almost surrounded by a hostile crowd and the Door Supervisors from the licensed premises also intervened to assist the Police Officers dealing with this incident, Officers had to draw their incapacitant sprays to keep the crowd at bay.

Two persons were arrested from this incident both for the offence of Drunk and Disorderly, contrary to section 91 of the Criminal Justice Act 1967.

As a direct result of this incident PC 113 D.Bryan and Mrs Groves East Northants District Council Licensing Enforcement Officer arranged to meet the Premises Licence Holder and his representative on the 29<sup>th</sup> of September 2015 also present were two representatives of a security company. The incident was debriefed and a way forward was discussed to promote the licensing objective of the Prevention of Crime and Disorder.

It was suggested by the police and agreed by the Premises Licence Holder that a condition was required to be added to the existing Premises Licence. This was done by way of a minor variation, the condition states:

On any day the premises remains open after 04:00am from 03:45am a minimum of two SIA registered door supervisors must be employed at the premises. On any day the premises does not employ SIA registered door supervisors, licensable activities shall cease at 03:45am and the premises shall close at 04:00am

The police at the hearing can explain the rationale for this approach to the identified problem and the wording of the condition.

On Saturday the 9<sup>th</sup> of January 2016 at 04:05am Police Officers were alerted to a scuffle in the High Street outside Luvly Jubly. The attending Officers noticed that Luvly Jubly was still trading without any door supervisors being present. The Officer reports that the staff had turned the lights of the premises off both inside and out and the outside shutters were pulled only slightly down, however the counter was full approximately 2 deep with customers purchasing hot food, the Officer states that inside the premises were in excess of 15 persons. The Officer also reports that there was a large amount of people outside the shop and this is where the scuffle had taken place.

This in Northamptonshire Police's view is a clear breach of the Premises Licence, trading in licensable activity should have ceased at 03:45am as the premises were not employing door supervisors. The licensable activity of the provision of late night refreshment is the serving of hot food and drink, not the ordering or purchasing of the hot food and drink. In addition the premises should have been closed to the public at 04:00am, the premises still had in excess of 15 customers still inside at 04:05am.

The additional information in relation to this breach of the premises licence is that the condition was designed to prevent disorder at the premises and control customers within to avoid the repeat of the incident in September 2015. However Officers attended the premises as there was a 'scuffle' outside the premises between Luvly Jubly's customers.

Northamptonshire Police are requesting that the Licensing Sub-Committee of East Northants District Council consider a reduction in the hours of the Premises Licence to 02:00am, however when the Committee are considering this request take account of whether further conditions and times will have any effect when the existing conditions and times are not adhered to.



In reference to the review application for the above premises I wish to make the following comments:

Due to police concerns over public order incidents happening at Luvly Jubbly, PC David Bryan and I visited the licence holder, Mr Batur at Luvly Jubbly on 24 September 2015. Mr Batur's Licensing Consultant and 2 owners of a security company were also present.

Although it was discussed that Mr Batur would find it useful to have door supervisors on Friday and Saturday evenings, Mr Batur's main concerned was cost rather than safety.

Mr Batur therefore applied for a minor variation of his premises licence on 30 September 2015 adding the following condition which was agreeable to PC Bryan and the Officers at East Northamptonshire Council:

'On any day the premises remains open after 04:00, from 03:45 a minimum of 2 SIA registered door supervisors must be employed at the premises. On any day the premises does not employ SIA registered door supervisors, licensable activities shall cease at 03:45 and the premises will close at 04:00'.

The licence was granted at the end of the 10 day consultation period.

On the evening of 4 December I visited the premises with PC Dougle Brown and PC Kelly Gadsden. At this visit Mr Batur advised that he cannot afford SIA registered door supervisors, so he closes the premises on time.

PC Brown had referred to another recent 'scuffle' that had occurred in the premises in previous weeks, however, Mr Batur denied this and stated that on that date customers were cleared from the premises and he had pulled down the shutters to stop further trouble.

Whilst working in the evenings, police officers have on a number of occasions mentioned their concerns to me over Luvly Jubbly and their concerns for the safety of the customers and staff.

When Fate closes, there can be up to 150 people in the High Street, with many of them wanting food and hanging around outside Luvly Jubbly waiting to be served. It is clear that 'scuffles' do take place and as per the Police statement after the 9 January 2016, a breach of the licence occurred and Mr Batur is not able to control these situations by himself.

I support PC Bryan's request to reduce the licensable hours at the premises, in order to stop further public order incidents and to protect staff and customers.

The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—

- (a) a holographic mark, or
- (b) an ultraviolet feature.
- 4. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

### If this premises licence requires the use of door supervisors.

- Where the premises licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity, each such individual must
  - (a) be authorised to carry out that activity by a licence granted under the Private Security Industry Act 2001; or
  - (b) be entitled to carry out that activity by virtue of section 4 of that Act.

## **Explanatory Notes and Definitions for Mandatory Condition 8.**

#### **Definitions**

"duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;

"permitted price" is the price found by applying the formula—

$$P = D + (DxV)$$

where—

- (i) P is the permitted price,
- (ii) D is the rate of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

"relevant person" means, in relation to premises in respect of which there is in force a premises licence—

- (i) the holder of the premises licence,
- (ii) the designated premises supervisor (if any) in respect of such a licence, or
- (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence:

"valued added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

Where the permitted price calculated would not be a whole number of pennies, it shall be taken to be the price calculated rounded **up** to the nearest penny.

## Annex 2 – Conditions Consistent with the Operating Schedule

The Licensee shall have installed and properly maintain in working order at all times a CCTV system. In particular this system shall:

Hold images for at least 28 days

Cover the area to which the public have access and any entrances/exits Staff will be trained in its operation

Images will be made available from the system to a Police Officer on request. I will have CCTV covering the shop. Recordings will be kept for 28 days. Recordings will be supplied to Police when necessary.

Sale of alcohol for consumption off the premises will be restricted to as an accompaniment to pre-ordered hot takeaway food delivered to residential addresses. For clarity, alcohol may not be sold with hot food purchased by a customer at the premises.

Staff trained in first aid.

Fire safety risk assessment.

Customers will be asked to leave quietly. If a customer is drunk or noisy they will not be served and will be asked to leave the premises. Notices will be displayed to this effect.

Children are not allowed in premises after 9:30pm. Challenge 21 policy applies.

The premises to adopt the Challenge 25 protocol of age verification. Customers ordering alcohol via the internet must tick a check box to confirm they are over 18. A written record of staff training must be kept. Refusals must be recorded and the record produced on request of an officer from a responsible authority. On any day the premises remains open after 04:00, from 03:45 a minimum of 2 SIA registered door supervisors must be employed at the premises. On any day the premises does not employ SIA registered door supervisors, licensable activities shall cease at 03:45 and the premises will close at 04:00.
