Application for a House to House Collection Licence

Summary

To consider an application by Galib Mujic for a House to House Collection Licence under Section 2 of the House to House Collection Act 1939

1.0 Introduction

- 1.1 An application to hold house to house collections in all areas of the district throughout the year was received on 2 June 2010.
- 1.2 The applicant's name is Galib Mujic, representing Global Recycling Aid Ltd, at 10 Chestnut Avenue, Corby.
- 1.3 An amount of £30 per tonnage from the collections will be given to "Hope for Children" at 14a Queensway, Hemel Hempstead a Registered Charity (Number 1041258).

2.0 Consideration of Application

- 2.1 A letter was sent to the applicant on 14 June requesting further information but no reply has been received.
- 2.2 A licensing authority may refuse to grant a Licence, or, where a Licence has been issued may revoke it, if it appears to the authority:
 - (a) That the total amount likely to be applied for charitable purposes as the result of the collection (including any amount already so applied) is inadequate in proportion to the value of the proceeds likely to be received (including any proceeds already received);
 - (b) That remuneration which is excessive in relation to the total amount aforesaid is likely to be, or has been, retained or received out of the proceeds of the collection by any person;
 - (c) That the grant of a licence would be likely to facilitate the commission of an offence under section three of the Vagrancy Act 1824, or that an offence under that section has been committed in connection with the collection;
 - (d) That the applicant or the holder of the licence is not a fit and proper person to hold a licence by reason of the fact that he has been convicted in the United Kingdom of any of the offences specified in the Schedule to this Act, or has been convicted in any part of His Majesty's dominions of any offence conviction for which necessarily involved a finding that he acted fraudulently or dishonestly, or of an offence of a kind the commission of which would be likely to be facilitated by the grant of a licence;
 - (e) That the applicant or the holder of the licence, in promoting a collection in respect of which a licence has been granted to him, has failed to exercise due diligence

to secure that persons authorised by him to act as collectors for the purposes of the collection were fit and proper persons, to secure compliance on the part of persons so authorised with the provisions of regulations made under this Act, or to prevent prescribed badges or prescribed certificates of authority being obtained by persons other than persons so authorised; or

- (f) That the applicant or holder of the licence has refused or neglected to furnish to the authority such information as they may have reasonably required for the purpose of informing themselves as to any of the matters specified in the foregoing paragraphs.

2.3 The application does not show what has been collected or donated in previous collections within East Northamptonshire Council's area or nationally. A low percentage donation appears likely from the indicated donation shown in the funding agreement and it is not clear how much the private company makes when undertaking these collections.

4.0 Recommendation

4.1 That the application for a House to House Collection Licence be considered to determine whether to issue or refuse the Licence.
